## Resolutions put forward and accepted at Congress - Monaco 2008

- 1) Ice Dance Discipline Be it resolved that the Figure Skating section at the 2008 ISU Congress proposes to ISU Congress to accept the principle that the Ice Dance discipline will be composed of two parts commencing in the 2010-2011 competitive calendar.
- 2) Be it resolved that between the time of this Congress and the happening of the 2010 Congress a fully articulated description of a proposed first segment for Ice Dance will be communicated. The test of the proposed first segment will use volunteer athletes, coaches and officials. A full proposal incorporating the results of the analysis and testing will be presented to the 2010 Congress for their consideration. Funding should be applied through the ISU Development program.

## Suggested guidelines for implementation

- IDTC oversees a working group of many Members to discuss and further develop ideas for the first segment for Ice Dance, incorporating the principles of compulsory dancing (June 2008 approximately November 2008).
- IDTC develops a Technical package for one or more technical descriptions distributed to Members to be used by volunteer teams and coaches in creating programs (January 2009).
- IDTC hosts a test event International competition in accordance with Rule 367 to test one or more of the segment ideas or in an other kind of event using officials from many Members and the athletes and coaches from as many members as possible volunteering to participate. Complete event to be video taped for further discussion and analysis (approximately June/July 2009) location tbd.
- IDTC analyzes of result of the test event )June/July 2009 November 2009)
- IDTC has continued communication with Ice Dance community through all events of 2008-2009 and 2009-2010 seasons.

- Proposals to be developed by the IDTC for the December deadline to be presented to the Members through the Congress agenda on normal calendar of communications – to be considered at the 2010 Congress.
- 3) ISU Novice Categories Be it resolved that following the recommendation as presented by the ISU Members in the Workshop at the 2008 ISU Congress, the Figure Skating section proposes to the ISU Congress to adopt a resolution asking the ISU Council to work on a definition of the Novice category for all ISU disciplines and to prepare corresponding proposals for the ISU Congress 2010. In the meantime, the Congress authorizes the Council to regulate, with the assistance of all advisory bodies, Novice competitions by Council decisions published in ISU Communications, respecting the age categories defined in the existing ISU Communications.
