NOVICE GRADE

ISU has just announced Guidelines for Novice Competitions.

Age Requirements:

In International Novice Competitions a Novice is a skater who has met the following requirements before July 1st preceding these Events.

- (i) may not be younger than ten (10) and must not have reached the age of fifteen (15) for Singles.
- (ii) must not have reached fifteen (15) for girls and seventeen (17) for boys for Pairs and Ice Dance.
- (iii) neither partner in the Pair or Ice Dance couple may be younger than ten.
- (iv) For Synchronized Skating, Novice teams are composed of skater all of whom have reached the age of ten (10) and have not reached the age of fifteen (15) before July 1st preceding the competition.

ISU have also standardized the Requirements for the Short Program and Freeskating, in Singles. Standardization of requirements for Ice Dance and Synchronized skating have also been established.

At present there are no plans to amend our Requirements for this Division in New Zealand or Australia.

TREASURER

Our current Treasurer Rosemarie Nye has advised of her resignation from this position to take effect from the 2003 Annual General Meeting. As per our Constitution she has completed her four years service and is therefore unable to stand again for this position. A request has already been sent out to Clubs to consider a suitable replacement, obviously a person with Accounting experience and the ability to use the present accounting system in place is preferred. They do not have to be a member of a Club but if a financial member of an ice-skating club then they receive a vote on Council.

Rosemarie also resigned from the Funding and Development portfolio taking effect immediately. Anne-Marie Frost who had already been assisting with development in Auckland has filled the position
